5. Installation of the machine will be done by Supplier's Engineers free of charges.
6. After the installation of the machine, the Supplier will impart training and orientation to the staff of PASTIC free of charges.
7. Warranty period of the machine must be mentioned which should not be less than one year.
8. If any fault/defect occurs in the machine during the warranty period, it will be done/replaced by the Supplier at his own risk and cost.
9. Period of service after the sale may be indicated
